**2024 contract between parent/learner and Arising Little Angels English Medium Christian School.**

Parent, in assuring that we work hand in hand and together in this marriage by God, we have to plan ahead as we are about to end this year and start a new year, 2024.

In assuring a good working and fruitful relationship, we must remind each other of the rules, regulations and policies of our organization and we must make sure that everyone abides by the rules so that we can continue with the fruitful nature of our relationship with both parties.

This binding contract of agreement is for a period of 12 months commencing or starting from the 1<sup>st</sup> of January 2024 up to the 15<sup>th</sup> of December 2024. Below are very important improvements to our 2024 academic school year and it is very important to familiarise and understand the content herein which follows:

**SCHOOL FEES FOR 2024**

School fees are R2000 per term and must be paid over 4 terms amounting to R8000 per year.

All school fees are due before or on the 7<sup>th</sup> day of the month of the start of a new term. School fees are payable per term and no monthly payments will be accepted, only term payments are accepted.



**The year plan will be attached and all year plan contributions (R400) must be included and paid with the first term school fees. 2024 year activities are R400 combined (once off) and it is expected that that amount/contributions must be paid with the first term school fees.**

Upon non-payment of school fees, the school has the right to terminate the services or terminate this contractual agreement between you, the client/parent/learner and the school, Arising Little Angels English Medium Christian School. Non-payment of school fees is a very serious offence and it warrants the termination of services as mentioned above.

- I have taken note of the school fees as communicated to me and available from the school office.
- All school fees are due on the 7<sup>th</sup> day for each term, failure to adhere to this, will result to prohibition to the school's premises.
- I understand that I have entered into an agreement/contract with the school, but the services are rendered to my child. Therefore failure from my side to comply with the rules or breach the contract that I have signed will result to the school terminating its services from my child.
- I accept full responsibility for all amounts due to the school and I agree to pay the school fees strictly according to due dates, failing which my child may be denied access to the school and even examinations.
- No learner with an outstanding balance for previous year will be re-registered unless the outstanding balance is paid in full.
- School fees are paid per term in advance but can also be paid per semester and annually in advance as well.
- All fees must be deposited through F.N.B –ATMs, with the correct reference[child's name, surname and grade]
- The school has the right to change reservation fee annually for current learners to reserve space for the following year.
- **PARENT, PLEASE DEPOSIT ALL SCHOOL FEES AT THE ATM AND MAKE SURE THE REFERENCE NUMBER IS THE NAME, SURNAME AND GRADE OF LEARNER. SHOULD YOU BE PAYING FOR TWO (2) CHILDREN OR LEARNERS, PLEASE COMBINE THE DEPOSIT BUT LIST THE LEARNERS AS YOUR REFERENCE AS THEY MUST ALL APPEAR ON THE DEPOSIT SLIP.**
- **UPON PAYMENT, SEND THE PROOF OF PAYMENT AND THE CLASS EDUCATOR MUST VERIFY IT AND MAKE SURE YOU GET THE SCHOOL RECEIPT. IT IS FULLY YOUR RESPONSIBILITY TO KEEP YOUR DEPOSITS SLIPS AS PROOF AS FROM TIME TO TIME WE WILL REQUEST THEM AS TO VERIFY FOR AUDIT SAKE.**
- **WE HAVE A PROBLEM WITH OUR IN CONTACT OR NOTIFICATION FROM FNB SO THOSE NOTIFICATIONS DO NOT COME THROUGH OR DO NOT APPEAR SO WE PLEAD WITH YOU REGARDING THE ABOVE POINTS TO KEEP YOUR DEPOSIT SLIPS AS PROOF AND MAKE SURE YOU DO GET A RECEIPT FROM THE SCHOOL.**
- **Please note, each parent is obliged to pay R2000 PER TERM/R4000 PER SEMESTER/ R8000 IN FULL. WE DO NOT ACCEPT MONTHLY PAYMENTS.**

### **LOST ITEMS**

Parent, charity begins at home. Let us teach our learners sense of responsibility and let them practice the “off the body and straight to your bag” mentality. It is a worrisome trend that we are held responsible for items lost outside the school’s premises as those that are lost inside in most cases are found at the lost and found. Items lost in the transports or outside the school’s premises, we are being held liable and given responsibility for those items. This contract must also serve as a notice and agreement that we won’t be held liable for lost items inside or outside the school’s premises and all items must be clearly marked with your child’s name and surname.

### **FLOOR POLISH**

As parents do not honour the office pack which is included in the start of the new year and in that, we must make sure that we have a new process of collecting it. So, at the start of the new year, 2024, it is required that each and every learner brings 4 Cobra wax floor polishes and it is compulsory that each and every learner brings them.

Parents we must honour this contract and it is required that each and every learner returning to the school for 2024 to sign and return this contract to school by no later than Friday, the 3<sup>rd</sup> of November 2023.



### **AGREEMENT AND DECLARATION**

- I undertake to uphold the values of Arising Little Angels English Medium Christian School wherever I am.
- We are a Christian school and Christianity is our religion, wearing of traditional beads is strictly prohibited, wearing of any string and of anything other than Christianity is strictly prohibited.
- I understand that this institution does not have an SGB but is governed by shareholders. However the dignity, views and concerns of the parents are not overlooked and can be communicated through the educators and sometimes the school principal.
- I understand that every child has got the right to basic education, but education at this institution is not basic, but independent school education. I as the parent chose this independent school for the benefits it has for my child's future.
- I understand that it is my child who is registered as a client at this school but in that, I take full responsibility for his/her actions and also, as the legal custodian of my child, he/she, as the client, will also be held liable and responsible for my misconduct or breaching the school rules, regulations, policies, financial and social utterances that may come about instituted by me.
- I will never speak ill of the school under any given situation. Should I be found guilty of such a misconduct, the school has every right to act upon that either by terminated our contract or being lawfully sued.
- I understand that false or misleading information in my application may result to my child not being accepted.
- I declare that the particulars furnished on this form are true and correct and I undertake to comply with the rules, regulations and decisions of the school, and any amendments thereto, which may be applicable to students and parents in general.
- I understand that the school has one annual general meeting ,at the beginning of the year, and three standing parents meetings (whose dates are clearly stipulated in the year plan) to support the education of my child.
- I will be available to attend parents meetings. When attending meetings I will be at my sober senses, I will be very polite, respectful, display Christian values and contribute positively towards the school.
- I am aware that the school has an open-door-policy and welcomes me to come and voice out my concerns and compliments without having to wait for the standing meetings. This will be done via making an urgent appointment through the schools admin clerks.
- I will respond timeously to letters, text messages and calls made by the school. I will communicate politely and in the most respectful manner when communicated with.
- I under take to keep all personal contact details updated at all times.
- I understand that posting anything negative on social media about the school will lead to my child being removed immediately from school, and that the school may sue me ,should I, my child or any person related to me does such.(POPIA ACT)
- Cell phones are strictly prohibited, any learner found in possession of a cell phone, that cell phone will be confiscated and it will have a release fee of R500. The parent/learner is liable for that fine and it won't be released until that fine is paid. Should it happen more than two



(2) times, then the cell phone will be confiscated and will only be released at the end of the year. The learner will also be detained (detention) should he/she be found in breach of this.

### **PHOTOS**

- I hereby grant permission for my child to be photographed participating in class projects and all school events and for the photographs to be included on the schools website, face book and other electronic devices ,media houses and social media.
- Should I attend any school activities, I will request permission to take photos that I will keep for good memories only.

### **INDEMNITY**

- I also understand that that this arrangement is necessary because it is sometimes difficult to get hold of parents to sign a letter of consent before a trip can take place. In such instances the child is unfairly prevented from attending a trip.

- I am fully aware that the school prohibits learners from wearing and possessing any traditional beads and any other stuff which represents other cultures and beliefs other than that of Christianity.
